No.GG/54/TTC/10(2002)/1310(Part-1)/C:- In exercise of the powers conferred by clause (u) of sub-section (1) of section 2 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023), in its application to the State of Gujarat, the Government of Gujarat hereby amends, the Government Notification, Home Department No. GG/44/TTC/10(2002)/1310/ V, dated the 30th April, 2005, as under:-
