
No. GG/ 78 /2025/DYS/102023/2665/B :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Deputy Superintendent of Police (Unarmed), Class I, Recruitment Rules, 2014 namely :-

1. (1) These rules may be called the Deputy Superintendent of Police (Unarmed), Class I, Recruitment (Amendment) Rules, 2025.
(2) They shall come into force on the date of their publication in the *Official Gazette*.
2. In the Deputy Superintendent of Police (Unarmed), Class I, Recruitment Rules, 2014 (hereinafter referred to as “the said rules”), in rule 2, -
 - (i) in clause (a), for the words “by promotion of a person of proved merit and efficiency”, the words, brackets and figures, “by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967” shall be substituted;
 - (ii) for clause (b), the following clause shall be substituted, namely:-

“(b) on the basis of the result of a combined competitive examination held for the purpose.”.
3. In the said rules, in rules 3, 4, 5, 6, 7, 8 and 9, for the words “by direct selection” wherever they occur, the words, “on the basis of the result of a combined competitive examination held for the purpose” shall be substituted.
4. In the said rules, in rule 4, -
 - (i) in clause (a), for the words and figures, “not be more than 30 years of age;” the words and figures, “not be more than 35 years of age;” shall be substituted;
 - (ii) in clause (b), sub-clause (i), for the word “degree”, the words, “bachelor’s degree” shall be substituted.

5. In the said rules, in the Appendix, in Part B, for the word “tor”, the word, “for” shall be substituted.
