No. G/G/37/2016/FSL102008/1037/A: - In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Director, in the General State Service , Class I, in the respective group of section or division of the Forensic Science Laboratory, Gujarat State, namely:-

- 1. These rules may be called the Assistant Director, Class I, in the Forensic Science Laboratory Recruitment Rules, 2016.
- 2. Appointment to the post of Assistant Director, in the General State in the respective group of section or division in the Service ,Class I, Forensic Science Laboratory, Gujarat State, shall be made either ,-
- (a) by promotion of a person of proved merit and efficiency from amongst
 - the persons, who,

(i) have worked for not less than eight years in the cadre of Scientific Officer, in the General State Service ,Class II, in the respective group of section or division of the Forensic Science Laboratory, Gujarat State, and (ii)have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses the experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

(b) by direct selection.

3. Appointment by promotion and direct selection shall be made in the ratio of 3:1 respectively in respective group of section or division of the Forensic Science Laboratory.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 45 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause(b) of subrule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General)Rules,1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

(b) (i) possess a Ph.D. or M. Phil degree in the respective group of section or division as specified in Annexure - I annexed to these rules, obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government; and

(ii) have about five years experience on the post not below the rank of Scientific Assistant, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State, in the respective group of section or division of the Forensic Science Laboratory; or

(iii)have about five years experience of research or analytical in the respective subject in the Government or Local Bodies or Government undertaking Board or Corporation ,which can be considered equivalent to the post not below the rank of the Scientific Assistant, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State; or

- (c) (i) possess a post -graduate degree with second class as specified in Annexure -I for respective group of section or division obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government; and
 - (ii) have about seven years' experience on the post not below the rank of Scientific Assistant, Class III, in the subordinate service of the Directorate of Forensic Science, Gujarat State, in the respective group of section or division of the Forensic Science Laboratory; or
 - (iii) have about seven years' experience of research or analytical in the respective subject in the Government or Local Bodies or Government undertaking Board or Corporation, which can be considered equivalent to the post not below the rank of the Scientific Assistant, Class III in the subordinate service of the Directorate of Forensic Science, Gujarat State.

Explanation : In these rules "Respective group of section /division" means a group of Section or division as shown in Annexure- I;

 (d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(e) posseses adequate knowledge of Gujarati or Hindi or both.

- 5. The candidate appointed by direct selection shall be on probation for a period of two years.
- 6. The candidate appointed by direct selection shall during his probation period require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rule, 2006.
- 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

- 8. The candidate appointed either by direct selection or by promotion shall require to undergo such training and pass such examination as may be presecribed by the Government.
- 9. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
