No. GG/66/2019/DYS/102017/65686/B: - In exercise of the powers conferred by the proviso to section 5 of the Gujarat Police Act, 1951 (Bom. XXII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Police Inspector (Unarmed), Class II, in the Gujarat Police Service, (Competitive Examination) Rules, 2017, namely :-

1. (1) These rules may be called the Police Inspector (Unarmed), Class II, in the Gujarat Police Service, (Competitive Examination) (Amendment) Rules, 2019.
(2) They shall be deemed to have come into force with effect on and from the 15th December, 2018.

2. In the Police Inspector (Unarmed), Class II, in the Gujarat Police Service, (Competitive Examination) Rules, 2017, in rule 17, for sub-rule (3), the following sub-rule shall be substituted, namely:-

"(3) The Commission shall prepare the waiting list showing the names of the successful candidates as far as possible for twenty percentage of the vacancies advertised for each category. The waiting list shall remain in force in accordance with the relevant rules issued by the Government in this behalf."
