No. GG/81/2020/DYS/102014 /272901/B In exercise of the powers conferred by section 21 of the Gujarat State Reserve Police Force Act, 1951 (Bom. XXXVIII of 1951), and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Company Commander/Armed Police Inspector, Class II, in the Gujarat State Police Service, namely:-

1. These rules may be called the Company Commander/ Armed Police Inspector, Class II, Recruitment Rules, 2020.
2. Appointment to the post of Company Commander/Armed Police Inspector, Class II in the Gujarat State Police Service shall be made by promotion of a person who possesses "good" bench mark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who
 - (i) have worked for not less than seven years in the cadre of Platoon Commander / Armed Police Sub-Inspector, Class III, in the Gujarat State Reserve Police Force;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006;
 - (iii) possesses valid driving license for Light Motor Vehicle;
 - (iv) have passed the physical efficiency test as may be prescribed by the Government:

Provided that where the appointing authority is satisfied that a person having an experience as specified in sub-clause (i)

above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period as specified in sub-clause (i) above:

Provided further that sub-clause (iii) shall come into force after one year from the date of publication of this notification in the *Official Gazette*:

3. The candidate appointed by promotion shall require to undergo such training and pass such examination as may be prescribed by the Government.
