AND WHEREAS, in the said book some highly indecent and objectionable remarks have been made by the author of the book against Mahatma Gandhi, the Father of the Nation;

AND WHEREAS, Mahatma Gandhi is a highly esteemed figure of this Nation and is highly respected not only all over the Country but all over the World;

AND WHEREAS, the Government of Gujarat is of the opinion that the remarks made against Mahatma Gandhi in the said book are likely to disturb the public tranquility;

AND WHEREAS, the Government of Gujarat is, of the opinion that every copy of such book in question should be forfeited;

NOW THEREFORE, in exercise of the powers conferred by section 95 of the Code of Criminal Procedure, 1973 (2 of 1974) read with section 153 A of the Indian Penal Code, 1860 (V of 1860), the Government of Gujarat hereby declares that every copy of such book found in the State of Gujarat be forfeited to the State Government.
